Sealed quotation are invited by the Executive Officer, Baripada Municipality, Baripada for auction sale of following condemned vehicle on "AS IS WHERE IS BASIS". The vehicles can be inspected by the bidders at the Municipality campus from 04.12.2017 to 16.12.2017 during office hours. The offer should be accompanied with a demand draft of Rs.5,000/-(Rupees five thousand)only as an earnest money drawn in favour of "Executive officer, Baripada Municipality" payable at Baripada on any Nationalized Bank. The bids will be accepted up to 03.30 P.M. of 18.12.2017 and will be opened on the same day i.e. on 18.12.2017 at 04.00 p.m. The bidders or their representative may remain present at the time of opening the bids. The highest bidder will have to deposit 50% of the bidding amount through Demand Draft/Bankers Cheque/Cash immediately after finalisation of the auction sale on spot failing which the earnest money deposited will be forfeited. The balance amount should be paid and the delivery of the auctioned vehicle is to be taken within seven days from the issue of the confirmed auction sale letter. In the event of failure on the part of the bidder to deposit the balance amount or to take delivery of the auctioned vehicle within stipulated period, the amount of earnest money and for instalment paid by the bidder shall stand forfeited.
